As part of an IFC-World Bank team, I am reviewing the literature on investment, human capital accumulation, training, research and development and economic growth and writing a paper recommending strategies for using efficient fiscal and non-fiscal incentives to encourage these activities to stimulate private investment and growth in the Philippines. I am also co-writing a paper which synthesizes the work of the team.

**Consultant** for Fiscal Incentives project for the Department of Finance, Philippines. United States Agency for International Development. December, 2005 – May, 2006. I computed the economic costs and benefits of providing fiscal incentives to attract investment. Using econometric models, I estimated the sensitivity of private investment in the Philippines to tax incentives (investment subsidies), as well as to other fundamental economic and non-economic factors. My work provided inputs for legislative advice to the Department of Finance and the Philippine Senate on rationalizing the system of fiscal incentives for private investment in the country and lowering the fiscal and social costs of non-transparent investment subsidy provision.

**Subject Specialist** on the Private Sector Participation in Public Infrastructure (PSP) for the Economic Policy and Reform Advocacy (EPRA) project, Ateneo de Manila University. United States Agency for International Development. October, 2005 - present. I serve as resource person, giving advice in support of advocacy for strengthening infrastructure policy with focus on private sector participation issues. I am presently writing a paper on contracts for private investment in infrastructure, emphasizing agency problems in government guarantees and tax incentives.
