Subject: Validation of Econ 11, Econ 101, and Econ 102 taken in other UP campuses;
Crediting of courses taken in previous degree program

1. Incoming shiftees and transferees who wish to obtain credit for 3-unit Econ 11, 4-unit Econ 101, and 4-unit Econ 102 not taken at UPSE must confirm online on or before 1 August 2025, 5:00PM via this link: <https://forms.gle/y7uREj13WYyMd4so7>. Those who did not signify their intention will not be allowed to take the exam. Refer to the table below to determine who may take the exam.

Course	Credit	Date of Validation Exam	Who may take the validation exam?
Econ 11	3	August 6, 2025 10:00 AM – 12:00 PM	Shiftees and transferees who completed 3-unit Econ 11 outside UPSE.
Econ 101	4	August 6, 2025 10:00 AM – 12:00 PM	Shiftees and transferees who completed 4-unit Econ 101 outside UPSE.
Econ 102	4	August 6, 2025 2:00 PM – 4:00 PM	Shiftees and transferees who completed 4-unit Econ 102 outside UPSE.

2. Incoming shiftees and transferees who will not take the exam at the scheduled time are assumed to have forfeited the opportunity to validate.
3. If a student passes the Econ 11 validation exam, the 3-unit Econ 11 taken in another UP campus will be credited as a substitute for the 3-unit Econ 11 offered by UPSE. A student who fails the validation exam must retake Econ 11 at UPSE. Moreover, the 3-unit Econ 11 taken in another UP campus will NOT be credited towards the BS Economics/BS Business Economics degree.
4. If a student passes the Econ 101 validation exam, the 4-unit Econ 101 taken in another UP campus will be credited as a substitute for the 4-unit Econ 101 offered by UPSE. A student who fails the validation exam must retake Econ 101 at UPSE. Moreover, the 4-unit Econ 101 taken in another UP campus will NOT be credited towards the BS Economics/ BS Business Economics degree.

5. If a student passes the Econ 102 validation exam, the 4-unit Econ 102 taken in another UP campus will be credited as a substitute for the 4-unit Econ 102 offered by UPSE. A student who fails the validation exam must retake Econ 102 at UPSE. Moreover, the 4-unit Econ 102 taken in another UP campus will NOT be credited towards the BS Economics or BS Business Economics degree.
6. Accepted shiftees and transferees who pass the validation exams for 4-unit Econ 101 and 4-unit Econ 102 but did not take Econ 11 yet must take Econ 11 at UPSE, preferably during the first semester of admission.
7. Accepted shiftees and transferees who successfully validated their 3-unit Econ 11, 4-unit Econ 101, and 4-unit Econ 102 must process the substitution within the first semester of admission to UPSE.
8. Accepted shiftees and transferees must process within first semester of admission to UPSE the crediting of all other creditable courses taken in their previous degree programs.
9. Accepted shiftees and transferees who took 3-unit Econ 101 and 3 unit-Econ 102 in other UP campuses may NOT take the validation exams for 4-unit Econ 101 and 4-unit Econ 102, respectively. However, their 3-unit Econ 101 and 3 unit-Econ 102 completed in other UP campuses may be credit as free electives towards the BS Economics or BS Business Economics curriculum.
10. Only 3-unit Econ 11, 4-unit Econ 101, and 4-unit Econ 102 may be validated for credit. All other Economics courses taken in other UP units or outside the UP System will not be credited towards a BS Economics or BS Business Economics degree.
